## New Little Library with a dog treat box

**Please come visit the new addition to our neighborhood!** My husband Bob Clardy and I have installed a Little Free Library with a dog treat box in front of our home at 100 Sun Rise Way.

The library contains an assortment of books for all ages. Books are always free for the taking. School supplies such as pens, pencils, crayons, highlighters, and composition books will occasionally also be available. Feel free to browse, take a book, or make a donation of a book. If you have multiple books that you wish to donate, please feel free to leave them on our front porch if they will not fit inside the library.

The dog treat box hosts a rotating variety of dog treats. A menu board lists that day's treat so you know what you are giving your dog. Treats are removed every night around 7:30 so they do not attract undesired overnight visitors. The dog treat box also houses a roll of pick-up bags so if a dog walker forgot to bring one along — or if it is "one of those days" when extra pick-up bags are needed — pick up bags are available. These bags are available 24/7.

We hope that the Little Free Library and associated dog treats add to your enjoyment of the neighborhood! Thank you, Elizabeth Bircher

# Why NOT to feed geese and wild animals

Did you know that by feeding the geese, ducks and other wildlife found here in Woodlake you are harming them? Wildlife that rely on humans for food lose their natural fear and may place themselves in dangerous situations, such as crossing roads in search of food. They also become aggressive toward humans.

## Other reasons not to feed the wildlife:

- Their droppings contain bacteria that pollutes the lake
- Their droppings contain bacteria and parasites that are harmful to people especially young children
- Geese damage the grass along the shorelines which leads to erosion
- By not sticking to their natural diet, they will suffer from poor nutrition and disease
- Feeding encourages them to stick around and will eventually lead to overpopulation
